Sub:- **Forwarding of Guidelines of Prime Minister's Scholarship Scheme (PMSS) for the wards of CAPFs/Assam Rifles personnel and States/UTs Police personnel of various States/Union Territories who are martyred during terror/naxal attacks under NDF for the Academic Year 2024-25 .**

In continuation to WARB, MHA letter No.WARB-44/PMSS/2024-25/922-32 dated 2nd July, 2024 and letter No. WARB-44/PMSS/2024-25/933-36 dated 2nd July, 2024.

2. In pursuance to the subject under reference, it is apprised that the PMSS guidelines for the academic year 2024-25 is enclosed herewith for information and further necessary action. It is further apprised that from the AY 2024-25, One Time Registration (OTR) is mandatory for applicants those who are applying for scholarship on National Scholarship Portal 2.0 (NSP 2.0). The complete details / instructions for students are available on National Scholarship Portal. NIC has made some other changes in National Scholarship Portal. Before applying for PMSS applicants should read the instructions carefully. As per PMSS guidelines, only online application are to be accepted and after lapse of due date, no any application will be entertained. Hence, as per the National Scholarships Portal / PMSS guidelines, candidates whose online application have not been verified online by the concerned Institutes/Nodal Officer i.e. Force Nodal Officer are not eligible for scholarship under fresh/renewal category.
